AND WHEREAS the Trustees have also accepted the trust fund as stated above;






- 22. The funds of the trust shall be invested in Bank Deposits, Government bonds or such other appropriate security as the Board of Trustees may decide.

- All acts and proceedings of the trust shall be taken and conducted in the name of the trust.
- 29. Nothing contained in this Deed of Trust shall be deemed to authorise the Trustees to do any act which may in any be/violative of Sec. 2(15), 11, 12, 12A, 13 and /or 80-G of the Income-tax Act, 1961 or any statutory modifications thereof and all activities of the Trust shall be carried out with a view to benefit the public as per the provisions of the Income-tax Act, 1961 or any statutory modifications thereof.
- 30. In the event of winding up of the Trust, the Trust shall be merged with othe trust or associations having similar objects and the assets of the Trust shall be disbursed to the Trust or Association with which the Trust is to be merged, and in no event they shall be appropriated either by the Trustees or any one related to the Trustees.
  - This trust is irrevocable.
